**Please note:** learners, parents/carers in receipt of working tax credit only are not entitled to a free meal.

For the 2023 to 2024 academic year, the rate set is £2.41 per learner per meal taken. Where a learner qualifies for free meals, this will apply for each day they attend their college provision, including any days they attend a work placement.
